- Delete *FNSRSK411 Apply risk management strategies to own work* as Core, as this unit does not suit the role requirements for learning undertaking this qualification.
- If an additional Core is needed, *FNSORG411 Conduct individual work within a compliance framework* is a better fit for the Industry. Adding this unit to Core will also require one less elective to be chosen for Packaging Rule purposes.

Elective Changes
